### SSI Beneficiaries Will See Double Payments in December 2023.

People with disabilities receiving Supplemental Security Income can expect to receive two payments this month, but one will be higher than the other.

The Social Security Administration says that SSI benefits were paid on Dec. 1 and another round will go out on Dec. 29.

Typically, SSI is issued on the first of the month, but if that day falls on a weekend or a federal holiday, the payment is sent in advance. As a result, beneficiaries can expect two checks to arrive this month, but nothing in January.

The maximum federal payment for individuals receiving SSI earlier this month was \$914 and \$1,371 for couples.

But, the next check will be larger thanks to an automatic cost-of-living increase taking effect in 2024. As a result, the top federal payment will grow to \$943 for individuals and \$1,415 for couples.

# Disability Advocates Working to End Sub-Minimum Wage.

Dozens of disability advocacy groups are urging the Biden administration to end a more than 90-year-old program allowing employers to pay workers with disabilities less than minimum wage. The American Association of People with Disabilities and other groups have been working quietly at the state level to make changes to this law, and have made some progress, currently 15 states have ended this practice, however; most states including New Mexico continue to pay sub-minimum wages to disabled persons in what is referred to as "sheltered employment".

Today, the Subminimum wage in New Mexico must be at least 50% of the standard minimum wage. The number translates to a requirement of at least \$5.75 per hour, or \$6.05 in Santa Fe County, while it's \$5.25 in Las Cruces. There are several categories of employees who can be paid at an even lower rate.

"The practice of paying disabled Americans subminimum wages is unfair, unjust and only further discriminates against our community that faces so many challenges already in our daily lives," said Maria Town, president, and CEO of the American Association of People with Disabilities. "People with disabilities deserve to be paid a fair wage regardless of their work environment. This practice has endured for 90 years. It's time for it to end."

Advocacy groups acknowledge that ending the subminimum wage program would require "time and resources to ensure that people with disabilities have the opportunity to successfully transition to their next step, and in a published statement, The Arc New Mexico said in part "[Arc NM] understands that some individuals who have been enrolled in "sheltered" programs earning less than minimum wage for decades will have challenges in transitions and are not advocating for immediate closure or discontinuation of those programs for those individuals until required by federal law and only then with careful transition planning."

#### A reminder from Alegria Family Services.

EORs must have their signed and dated VPRs into our office no later than 9:00am each Monday to avoid interruptions in payments to providers. Also, if you provide CCSI (Navigation), and your notes are on paper, they must be in the office by 9:00am each Monday to be submitted on time for payment. Lastly, if you are like most CCSI providers, you are submitting your notes digitally using the AFS digital documentation process. Remember that weeks run from Sunday at 12:00am to Saturday at 11:59pm. You must have your notes digitally signed and submitted by Saturday night at 11:59pm. AFS will process your notes and submit them for payment by the Monday 9:00am deadline. To ensure the best possible results, your notes should be entered and updated into our system daily, as services are provided. This will always insure the most accurate and timely reporting. #### The truth about Rudolph the Red-Nosed Reindeer

Rudolph the Red-Nosed Reindeer first appeared in 1939 when Montgomery Ward department store asked one of its copywriters, 34-year-old Robert L. May, to create a Christmas story the store could give away to shoppers as a promotional qimmick.

The retailer had been buying and giving away coloring books for Christmas every year; and it was decided that creating its own book would save money. In the first year of publication, 2.4 million copies of Rudolph's story were distributed by Montgomery Ward.

May's brother-in-law, songwriter Johnny Marks, decided to adapt the story of Rudolph into song.

Marks' musical version of "Rudolph the Red-Nosed Reindeer" was recorded by Gene Autry in 1949.



# IHLS Progress Notes Important Documentation for the Mi Via Waiver

Your progress notes are the single most important documentation completed each month. When done properly, they provide the justification for billing each day's services, create an accurate record of the daily life of the participant, and help ascertain what future needs the participant may require in the upcoming budget years. Unfortunately, because of the very nature of caring for participants on the Mi Via Waiver, details are often overlooked, and repetition becomes standard when recording daily progress notes. This creates an unclear and often incomplete record of the participants' life and their involvement with providers. As with all New Mexico waivers, DDSD audits can and do happen on the Mi Via Waiver. Taking care to give accurate and detailed progress notes each month can help avoid findings by DDSD that could result in expensive reimbursements of funds.

Currently Mi Via notes do not require time in and time out entries, however your notes should describe your days interactions with your individual with enough detail to easily depict 4 or more hours of assistance by the provider per day. We understand that daily routines are often repetitious by nature, but far too often we see notes that simply repeat the same sentence or phrase for each day, with little or no variation. This is because we do the same thing each day for our participants, and since their lives do not vary much, our progress notes do not vary much. So how do we break the monotony of our daily

notes? How can we give a more comprehensive and complete picture of our daily involvement with our participants? This question is asked more often than most people would think. We hope to offer some ideas for consideration.

If you regularly provide assistance with mealtimes, medications, or hygiene, pick any one of these tasks and focus on the details of what you did. What assistance did you provide? Did you help your participant with the cooking, or did you do it yourself? If you helped, does your participant enjoy cooking with you? Was the meal enjoyable for the participants and you? How much time was spent doing this task? Change the focus on tasks daily, choosing one to discuss each day.

Always give complete details on doctor or therapy visits and any other out of the house activity. Our participants often need more support during these out-of-routine events. What was needed from you to make this event go smoothly? Give details and include who, what, where, when, and how to the narrative.

With practice, patience, and care, your notes will always pass any scrutinization that may come. In the long run this benefits your participant and your associated agencies as well as yourself. You can always contact Alegria Family Services for help and guidance when completing your notes.
